

What to Know About PCQI Training Version 2.0

Can I still take HACCP course if PCQI will be updated?

This does not impact the HACCP portion of your package. You can start with HACCP and be upgraded to PCQI 2.0.

What's happening to Version 1.2 of the PCQI course?

FSPCA is officially retiring Version 1.2. The last day to enroll in training and receive a Version 1.2 certificate with our course is **June 30th, 2025**. After that, only Version 2.0 will be available.

Can I still get certified if I'm enrolled in Version 1.2?

Yes, but you must complete the course within your year of access.

What if I don't finish Version 1.2 by the deadline?

If you have started Version 1.2, you can complete and receive your certificate.

If you have **not started** version 1.2, you'll be automatically upgraded to Version 2.0 at no additional cost when it launches in July 2025.

Will I need to start over if I switch to Version 2.0?

Yes, Version 2.0 is a significantly updated curriculum. You'll need to complete the full course to receive the new FSPCA official certificate.

Is there a refresher course for those who already completed Version 1.2?

No, there is no refresher. The full Version 2.0 course must be taken to receive a new certificate (per FSPCA).

Will my Version 1.2 certificate still be valid?

Yes. FSPCA certificates do not expire. Version 2.0 reflects the FDA's most current guidance.

What's new in Version 2.0?

Version 2.0 includes updated hazard analysis aligned with FDA's latest thinking, reorganized content, more real-world examples, and streamlined chapters to reduce redundancy.

Is Version 2.0 recognized by the FDA?

Yes. Version 2.0 is recognized as the standardized curriculum as of October 2024.

When will Version 2.0 be available?

Our 100% online, self-paced Version 2.0 course will launch in July 2025.

What does "self-paced" mean?
